GLOBALEX - GUIDELINES (28 June 2018)

## NAME

The name of the alliance shall be Globalex.

## AINS

The aims of Globalex shall be to facilitate collaboration and knowledge-sharing among its Members and others concerning lexicography and related areas of linguistics and language technology, and the activities of the CAs (as described below) and other relevant bodies; to promote the research, development, exchange, dissemination and usage of lexicographic resources and solutions; and to enhance the interoperability of lexicography with other domains and with the academia and industry worldwide.

In furtherance of these aims, Globalex shall develop websites, organize and sponsor workshops, conferences and other events, and disseminate publications, video and audio recordings and any other information and materials of interest to its Members, partners and the general public.

## MANAGEMENT

Globalex shall be managed by a Management Committee (MC) comprising representatives of the five founding Continental Associations (CAs):

- African Association for Lexicography (<u>Afrilex</u>)
- Asian Association for Lexicography (<u>Asialex</u>)
- Australasian Association for Lexicography (<u>Australex</u>)
- Dictionary Society of North America (DINA)
- European Association for Lexicography (Eurales)

Each CA shall appoint at its discretion one representative to the MC (Member). Other than the Chair and Vice-Chair, as described below, each Member shall serve on the MC for a two-year period. The Chair and Vice-Chair shall each serve on the MC for a period of three years.

The MC shall elect the Chair and Vice-Chair in its first meeting. The Chair and Vice-Chair shall prepare meeting agendas and shall represent Globalex in communication with other entities.

The MC may invite additional Members to the MC at its discretion.

All decisions by the MC shall require approval by three quarters of its Members,

Changes to these Guldelines require unanimous approval by the five CAs.

The MC shall meet at least each quarter year. Meetings can be physical or virtual.

A written record of all meetings and actions taken by the MC shall be kept. Each Member shall take steps to communicate such records to her/his CA.

## MEMBERSHIP

Globalex welcomes active involvement and participation of any association, institution or network, wherever located, engaged in lexicography in any of its aspects. Participation is voluntary and free. Initiatives are welcome subject to approval by and in coordination with the MC.
